

Radiant Life Affiliate Agreement

Effective 2026

BY SUBMITTING AN AFFILIATE APPLICATION ON OUR SITE, CHECKING A BOX INDICATING YOUR AGREEMENT TO THESE TERMS, CLICKING ANY BUTTON LABELED "SUBMIT," "APPLY," "I AGREE," OR ANY SIMILAR AFFIRMATIVE ACTION, OR BY OTHERWISE PARTICIPATING IN THE PROGRAM, YOU ACKNOWLEDGE THAT YOU HAVE READ, UNDERSTOOD, AND AGREE TO BE LEGALLY BOUND BY THIS AGREEMENT IN ITS ENTIRETY, INCLUDING THE CONTENT LICENSE IN SECTION 10, THE MODIFICATION RIGHTS IN SECTION 15, AND THE ARBITRATION AND CLASS ACTION WAIVER IN SECTION 19. NO PHYSICAL OR ELECTRONIC SIGNATURE IS REQUIRED. IF YOU DO NOT AGREE TO THESE TERMS, DO NOT SUBMIT AN APPLICATION AND DO NOT PARTICIPATE IN THE PROGRAM.

This Agreement contains the complete terms and conditions that apply to your participation in the RadiantLifeCatalog.com Affiliate Program (the "Program"). As used in this Agreement, "we," "us," and "Radiant Life" mean Radiant Life Company, and "you" and "Affiliate" mean the applicant. By "site" and "website" we mean a World Wide Web site on the Internet and, depending on the context, refers either to the RadiantLifeCatalog.com web site (www.radiantlifecatalog.com) or to any site, social media account, email list, podcast, video channel, or other digital property from which you will link to our site (and which you identify in your Program application).

1. Enrollment in the Program

To begin the enrollment process, submit a complete Program application. We will evaluate your application in good faith and will notify you of your status. We qualify your application based on your professional services and certifications. We also evaluate the quality of your website, blog, social channels, or other digital properties. Finally, we evaluate whether your content is consistent with our editorial policies and mission.

We may reject your application if we determine, at our sole discretion, that your site is unsuitable for the Program. Unsuitable sites include those that:

- Promote sexually explicit materials.
- Promote violence or discrimination based on race, sex, religion, nationality, disability, sexual orientation, gender identity, or age.
- Promote illegal activities or otherwise violate intellectual property rights.
- Engage in unsolicited bulk emailing (also known as spam) or violate the CAN-SPAM Act or comparable laws.
- Promote misinformation, deceptive health claims, or content that materially misrepresents our products or their benefits.

- Rely primarily on paid traffic that Radiant Life has not preapproved in writing.

By participating in the Program you agree that you will not engage in any such activities. If we reject your application, you are welcome to reapply to the Program at any time. If we accept your application and later determine, in our sole discretion, that your site or promotional conduct is unsuitable for the Program, we may terminate this Agreement.

2. Links on Your Site

After your site has been accepted into the Program, we will provide you with tracking links to add to your site. To permit accurate tracking, reporting, and commission accrual, we will provide you with a special tagged link to be used in all links between your site and our site ("your unique link"). You must ensure that this link functions properly.

You will earn commissions only if the initial order originated through your unique link. We will not be liable to you with respect to any failure to use your unique link, including any such failure that may result in a reduction of amounts that would otherwise be paid to you. You acknowledge that, by participating in the Program and placing the above links within your site, Radiant Life may receive information from or about visitors to your site. Your participation in the Program constitutes your specific and unconditional consent to and authorization for Radiant Life's use of such information, consistent with the policies and procedures set forth in Radiant Life's Privacy Policy.

You acknowledge that we may monitor your site for the purpose of ensuring the quality and reliability of your unique link (for example, to detect links that are broken or non-functional, links to products that are out of stock or otherwise unavailable, etc.). Further, you agree that you will: (a) not sell, redistribute, sub-license, or transfer any Radiant Life content; and (b) promptly delete any content that is no longer displayed on the RadiantLifeCatalog.com site or that we notify you is no longer available for your use.

3. Attribution and Cookie Window

Our affiliate tracking system uses a one hundred eighty (180) day cookie attribution window. A qualifying purchase made by a customer within 180 days of clicking your unique link will be attributed to your account, provided no other affiliate's unique link is clicked in the intervening period. Where multiple affiliate clicks occur within the attribution window, last-click attribution applies unless we determine, in our sole discretion, that a different allocation is appropriate to prevent abuse or ensure fairness.

4. Order Processing, Fulfillment, and Reporting

We will process product orders placed by customers who follow your unique link from your site to our site. We reserve the right to reject orders that do not comply with any requirements that we may

establish periodically. We will be responsible for all aspects of order processing and fulfillment. Among other things, we will prepare order forms, process payments, cancellations, and returns, and handle customer service. We will track sales made to customers who purchase products using your unique link and will make available to you reports summarizing this sales activity. The form, content, and frequency of the reports may vary from time to time and at our discretion.

5. Referral Fees

We will pay you referral fees on product sales made on our site. For a product sale to be eligible to earn a referral fee, the customer must click through your unique link from your site to our site and add the product to their shopping cart, with the initial attribution occurring within the 180-day cookie window described in Section 3. We will pay referral fees only after order, payment, and shipping have occurred and any applicable return window has expired.

You may not: (a) in any way modify, redirect, suppress, or substitute the operation of any button, link, or other interactive feature of our site; (b) take any action that could reasonably cause any customer confusion as to our relationship with you, or as to the site on which any functions or transactions (such as search, order, or browse) are occurring; (c) attempt to intercept or redirect, including without limitation via user-installed software, browser extensions, cookie stuffing, iframe stuffing, forced clicks, or typosquatting, traffic from or on, or divert referral fees from, any web site that participates in the Program; (d) seek to purchase or register any keywords, search terms, domain names, or other identifiers that include the words "radiant life," "radiantlife," "radiantlifecatalog," or any misspelling or variation thereof for use in any search engine, portal, sponsored advertising service, or other search or referral service; or (e) operate any coupon, deal, discount, cashback, or loyalty site that promotes Radiant Life without our prior written approval, which may be granted, conditioned, or withheld in our sole discretion.

If we determine, in our sole discretion, that you have engaged in any of the foregoing activities, we may, without limiting any other rights or remedies available to us, withhold any referral fees otherwise payable to you under this Agreement, reverse previously paid referral fees, and terminate this Agreement.

6. International Affiliates

If you are applying to be a Radiant Life Affiliate and do not live in the United States, we still welcome you to apply. However, all international affiliates will be paid in US dollars and held to the same terms and conditions in this agreement as US-based affiliates. Additionally, all international affiliates are responsible for setting up their own PayPal account or other payment method we accept, as that is the means for receiving affiliate payments. You are solely responsible for any currency conversion fees, taxes, customs, or regulatory obligations in your jurisdiction.

7. Referral Fee Schedule

You will earn referral fees based on Qualifying Revenues according to referral fee schedules established by us from time to time. "Qualifying Revenues" are revenues derived by us from sales of our products, excluding taxes, shipping charges, refunded amounts, and returned items. For qualifying products sold to customers attributed to your unique link, you will earn, subject to the other terms of this Agreement, referral fees as follows:

- 10% of Qualifying Revenues from each initial order and each subsequent order attributed to your unique link within the 180-day attribution window.
- To continue to receive revenues from subsequent orders you must maintain active internet links or content that bring a minimum of two new customers within a six-month period. A "customer" is defined as a person that places an order. Inactive affiliates will be removed from the Program and ineligible for future commissions.

8. Referral Fee Payment

We will pay you referral fees on a monthly basis. Approximately 30 days following the end of each month, we will either (a) send payment via PayPal or another electronic payment method we support, or (b) at our discretion and with your agreement, issue a gift certificate good for purchase of products through our site, subject to our standard terms and conditions. We will accrue and withhold referral fees until the total amount due is at least \$50.00. You are responsible for providing and maintaining accurate payment information. We are not liable for failed payments resulting from incorrect or outdated account details.

9. FTC Disclosure and Endorsement Compliance

You agree to comply with all applicable laws and regulations governing endorsements, testimonials, and advertising, including the U.S. Federal Trade Commission's Guides Concerning the Use of Endorsements and Testimonials in Advertising (16 CFR Part 255) and the FTC Endorsement Guides as updated. This includes but is not limited to:

- Clearly and conspicuously disclosing your material connection to Radiant Life in all content that promotes our products, including but not limited to website posts, blog articles, emails, social media posts, stories, reels, videos, podcasts, and livestreams.
- Placing disclosures before any affiliate link, product recommendation, or promotional claim, in a manner that is unavoidable and readable to the average consumer. Disclosures buried in hashtag clusters, footers, bio links only, or behind "more" expanders do not satisfy this requirement.

- Using plain-language disclosure such as "#ad," "paid partnership," "affiliate link," or "I earn a commission from purchases made through this link."
- Making only truthful claims about our products. You may not make health, medical, or performance claims beyond those supported by Radiant Life's approved marketing materials, and you may not claim products diagnose, treat, cure, or prevent any disease.

You agree to indemnify and hold Radiant Life harmless from any claims, fines, or penalties arising from your failure to comply with disclosure or advertising laws.

10. Content License to Radiant Life

This Section 10 is a material term of this Agreement.

By participating in the Program and by submitting, posting, tagging, or otherwise making available any content that features, references, or is associated with Radiant Life or our products (including but not limited to photographs, videos, reels, stories, livestreams, blog posts, written testimonials, product reviews, audio recordings, graphics, illustrations, and any likenesses, voices, or performances of you or persons who have authorized you to use them), and including content you submit directly to us, post to your own channels, or publish in response to a Radiant Life campaign, request, or product seeding (collectively, "Affiliate Content"), you grant Radiant Life a worldwide, perpetual, irrevocable, royalty-free, fully paid-up, sublicensable, and transferable license to use, reproduce, distribute, publicly display, publicly perform, modify, adapt, edit, crop, resize, translate, create derivative works from, and otherwise exploit the Affiliate Content, in whole or in part, in any and all media now known or hereafter developed, for any purpose related to Radiant Life's business, including without limitation:

- Paid and organic advertising across all platforms, including Meta (Facebook and Instagram), TikTok, YouTube, Google, Pinterest, X, Snapchat, LinkedIn, and any successor or new platforms.
- Email marketing, SMS marketing, and other direct marketing channels.
- Our website, landing pages, product detail pages, blog, and any microsites.
- Our owned social media accounts, including reposts, reshares, stitches, duets, and story features.
- Print materials, packaging, point-of-sale displays, trade show materials, and retail partner marketing.
- Press, public relations, investor materials, and internal communications.
- Any combination, compilation, or derivative use of the Affiliate Content alongside other content, including but not limited to Radiant Life's own brand assets, other affiliates' content, and third-party content.

You represent and warrant that: (a) you own or have secured all rights, consents, releases, and permissions necessary to grant this license, including from any individuals, minors' guardians, or rights

holders appearing in or contributing to the Affiliate Content; (b) the Affiliate Content does not infringe any third party's intellectual property rights, rights of publicity, privacy rights, or any other rights; (c) no additional payment, attribution, or approval will be required from you, any depicted individual, or any third party in connection with our use of the Affiliate Content as licensed herein; and (d) any music, voiceover, or third-party material embedded in Affiliate Content is properly licensed for the commercial and advertising uses contemplated by this Agreement, or we may, at our option, remove or replace such material before use.

This license survives termination of this Agreement. Radiant Life is not obligated to use any Affiliate Content, to credit or identify you when we do use Affiliate Content, or to compensate you beyond the referral fees described in this Agreement. If we do credit you, we may use your name, handle, or likeness in good faith to do so.

If you do not want specific content to be licensed to Radiant Life under this Section, you must clearly mark that content "Not Licensed to Radiant Life" at the time of creation and before making it publicly available. Content that tags, mentions, or links to Radiant Life or our products without such marking is deemed Affiliate Content and is licensed as provided above.

11. Limited License to Affiliate

We grant you a nonexclusive, revocable, non-transferable right to use the Radiant Life name, logos, graphic images, product photography, and approved marketing text (collectively, "Radiant Life Materials") solely for the purpose of identifying your site as a Program participant and to assist in generating product sales. You may not alter Radiant Life Materials, use them in a misleading or disparaging manner, or combine them with materials that could reasonably confuse consumers as to the source of products. We reserve all rights in our Radiant Life Materials, our trade names and trademarks, and all other intellectual property rights. We may revoke your license at any time by giving you written notice.

12. Data Privacy

You agree to comply with all applicable privacy and data protection laws in connection with your participation in the Program, including without limitation the California Consumer Privacy Act and California Privacy Rights Act (CCPA/CPRA), the Telephone Consumer Protection Act (TCPA), the CAN-SPAM Act, and applicable state and international privacy laws. If you collect email addresses, phone numbers, or other personal information from visitors you refer to Radiant Life, you are responsible for obtaining all legally required consents. You may not share with Radiant Life any personal information collected in violation of applicable law, and Radiant Life may refuse to accept referrals or commissions associated with non-compliant data collection.

13. Responsibility for Your Site

You will be solely responsible for the development, operation, and maintenance of your site and for all materials that appear on your site. This includes:

- The technical operation of your site and all related equipment.
- Creating and posting product descriptions on your site and linking those descriptions to our catalog, consistent with our approved claims and disclosures.
- The accuracy and appropriateness of materials posted on your site, including all product-related materials.
- Ensuring that materials posted on your site do not violate or infringe upon the rights of any third party, including copyrights, trademarks, privacy, rights of publicity, or other personal or proprietary rights.
- Ensuring that materials posted on your site are not libelous, deceptive, or otherwise illegal.
- Ensuring that you do not represent your site to be the Radiant Life site or imply an employment, partnership, agency, or joint venture relationship with Radiant Life.
- Ensuring that your emails and messages do not appear to originate from Radiant Life and comply with all anti-spam and marketing laws.
- Maintaining active internet links or content that bring a minimum of two new customers within a six-month period. Inactive affiliates will be removed from the Program and ineligible for future commissions.

We disclaim all liability for these matters. You will indemnify and hold us harmless from all claims, damages, and expenses, including without limitation reasonable attorneys' fees, relating to the development, operation, maintenance, and contents of your site and your participation in the Program.

14. Term of the Agreement

The term of this Agreement will begin upon our acceptance of your Program application and will end when terminated by either party. Either you or we may terminate this Agreement at any time, with or without cause, by giving the other party written notice of termination, which may be provided by email. Upon termination of this Agreement for any reason, you will immediately cease use of, and remove from your site, all links to our site and all Radiant Life trademarks, trade dress, and logos, and all other materials provided by or on behalf of us to you pursuant to this Agreement or in connection with the Program.

You are eligible to earn referral fees only on sales of products that occur during the term, and referral fees earned through the date of termination will remain payable only if the related orders are not canceled or returned. We may withhold your final payment for a reasonable time to ensure that the

correct amount is paid. The content license granted to Radiant Life under Section 10 survives termination.

15. Modification

We reserve the right to modify, amend, supplement, or replace any of the terms and conditions contained in this Agreement at any time, without prior notice to you, in our sole and absolute discretion. Modifications become effective immediately upon posting a change notice, revised agreement, or updated program rules on our site, or upon any other form of notice we elect to provide. Modifications may include, without limitation, changes in the scope of available referral fees, referral fee schedules, payment procedures, cookie window, attribution rules, eligibility requirements, prohibited conduct, content license terms, and any other Program rules. It is your responsibility to review this Agreement periodically. Your continued participation in the Program after any modification constitutes your acceptance of the modified terms. If you do not agree to a modification, your sole remedy is to terminate this Agreement and cease participation in the Program.

16. Relationship of Parties

You and we are independent contractors, and nothing in this Agreement will create any partnership, joint venture, agency, franchise, sales representative, or employment relationship between the parties. You will have no authority to make or accept any offers or representations on our behalf. You will not make any statement, whether on your site or otherwise, that reasonably would contradict anything in this Section.

17. Limitation of Liability

We will not be liable for indirect, special, incidental, consequential, or punitive damages, or any loss of revenue, profits, goodwill, or data, arising in connection with this Agreement or the Program, even if we have been advised of the possibility of such damages. Our aggregate liability arising with respect to this Agreement and the Program will not exceed the total commissions paid or payable to you under this Agreement in the twelve months preceding the event giving rise to liability.

18. Disclaimers

We make no express or implied warranties or representations with respect to the Program or any products sold through the Program, including without limitation warranties of fitness, merchantability, non-infringement, or any implied warranties arising out of a course of performance, dealing, or trade usage. In addition, we make no representation that the operation of our site will be uninterrupted or error-free, and we will not be liable for the consequences of any interruptions or errors.

19. Arbitration

Any dispute relating in any way to this Agreement, including any actual or alleged breach hereof, any transactions or activities under this Agreement, or your relationship with us or any of our providers, shall be submitted to confidential binding arbitration in Clark County, Nevada, administered by the American Arbitration Association under its Commercial Arbitration Rules, except that, to the extent you have in any manner violated or threatened to violate our intellectual property rights or the content license in Section 10, we may seek injunctive or other appropriate relief in any state or federal court in the State of Nevada (and you consent to non-exclusive jurisdiction and venue in such courts) or any other court of competent jurisdiction. You and Radiant Life each waive any right to a jury trial and any right to participate in a class action or consolidated proceeding.

20. Miscellaneous

This Agreement will be governed by the laws of the United States and the State of Nevada, without reference to rules governing choice of laws. You may not assign this Agreement, by operation of law or otherwise, without our prior written consent. Subject to that restriction, this Agreement will be binding on, inure to the benefit of, and be enforceable against the parties and their respective successors and assigns. Our failure to enforce your strict performance of any provision of this Agreement will not constitute a waiver of our right to subsequently enforce such provision or any other provision of this Agreement. If any provision of this Agreement is held unenforceable, the remaining provisions will remain in full force and effect. This Agreement, together with our Privacy Policy and any referral fee schedule or program rules referenced herein, constitutes the entire agreement between the parties regarding the Program and supersedes all prior agreements and understandings.

THIS IS A LEGAL AGREEMENT BETWEEN YOU AND RADIANT LIFE. BY SUBMITTING AN AFFILIATE APPLICATION ON OUR SITE OR OTHERWISE PARTICIPATING IN THE PROGRAM, YOU AGREE TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS AGREEMENT, INCLUDING THE CONTENT LICENSE IN SECTION 10, THE MODIFICATION RIGHTS IN SECTION 15, AND THE ARBITRATION AND CLASS ACTION WAIVER IN SECTION 19. NO PHYSICAL OR ELECTRONIC SIGNATURE IS REQUIRED FOR THIS AGREEMENT TO BE BINDING. PLEASE READ THIS ENTIRE AGREEMENT CAREFULLY BEFORE SUBMITTING YOUR APPLICATION.
